

Stallion Service Agreement and Breeding Contract for fresh / chilled semen.

The Stallion owner agrees to supply fresh/chilled semen from the Stallion Rivoli Magnus for the nominated mare,
with Live Foal Guarantee / Return Service, subject to the following terms and conditions:

1. The service fee of \$1500, which includes a non refundable booking fee of \$300, is to be paid in full before the collection and shipment of semen.
(Your first collection will be free of the collection charge, subsequent collection fees of \$250 will apply plus \$70 for consumables eg extender, syringes etc... if required)
2. The mare owner agrees to pay directly to Lee Bason for the collection fee and freight fees applicable to ship the semen to the mare owner's qualified vet/nominated address, before the collection of the semen.
3. The mare owner understands LFG entitles the mare owner to a return breeding to the Stallion Rivoli Magnus with the same mare, in the next breeding season, subject to the below items 4 &
- 5.
4. The mare owner must understand that the LFG applies only when, the mare:
 - a. Fails to conceive .
 - b. Aborts the foetus.
 - c. the foal dies within 24 Hours of birth, whereby a vet certificate must be supplied.
5. The LFG will be void if the Mare Owner:
 - a. fails to have a vet examine the pregnancy for twins or abortions at or before eighteen (18) days after insemination, and also between Forty (40) and Sixty (60) days after insemination.
 - b. does not endeavour to maintain the pregnancy with proper veterinary checks, care and maintenance of the pregnant mare with appropriate feed, water and shelter.
 - c. fails to notify the stallion owner of the results within 7 days for the above outlined pregnancy tests.
 - d. the LFG does not apply if the mare is sold, exported or dies.
 - e. a return service will be given if a pregnancy test proves negative 42 days after service. Veterinary certificate is required. The return service is to be taken the following season and will incur booking fee, collection and freight costs (a booking fee may be waived at the discretion of the stallion owner)
6. The Stallion owner reserves the right to refuse any mare for breeding.
7. The mare owner/s are advised to have their mare/s assessed for breeding suitability before breeding by a qualified veterinarian. If the mare becomes unbreedable for any reason the mare owner may nominate a second mare for breeding on approval from Stallion owner.
8. Service fees are not refundable except if between paying for the service and supplying semen, the Stallion

should

be unable to supply semen due to injury, sickness or death.

a. Change of mindset forfeits the booking fee of \$300.

9. The Mare owner will give minimum 48hours notice to be able to supply semen to the designated certified address.

10. Semen will be limited to 3 inseminations to obtain a pregnancy, and after two failed inseminations, a vet report is

required to recommend continuing and that the mare is suitable for breeding.

11. Frozen semen maybe substituted for fresh semen if fresh/chilled is for whatever reason, unavailable.

12. The Stallion owner is not liable for lost, delayed or damaged semen due to circumstances beyond their control.

13. Gelding Policy – All colts born sired by Rivoli Magnus must be gelded prior to 30 months of age and

must not serve any mares during their lifetime. Veterinary certificate of gelding is required.

If the colt foal has been sold in-utero or after birth, it remains the responsibility of the signatory of this

contract to ensure the new owner is aware of this gelding policy and to forward the acknowledgment to

Lee Bason.

14. All veterinary costs applicable to the mare are the responsibility of the mare owner.
